Dear Members,

Further to the Communique regarding the forthcoming AGM 2021, we are pleased to inform you of the following:

1. Only compliant members (members who have paid their membership fees and are not in arrears with the Association) will be allowed to participate in the AGM.
2. Nomination papers will be made available as from **Tuesday 19th January 2021** for any member who wishes to stand as candidate for the election of the Bar Council. Kindly contact Kevina.
3. A candidate must ensure that his/her nomination paper is duly deposited at the Seat of the MBA by **Wednesday 20th January 2021 at 15:00 p.m. latest**. No nomination paper will be accepted after that time.
4. Every candidate must ensure that his/her nomination paper is duly signed by at least two compliant members of the MBA indicating clearly on the nomination paper, the members' postal addresses and email addresses.
5. The list of candidates will be communicated to all members of the Association on **Wednesday 20th January 2021**.
6. Withdrawal of candidacy should be done on or before **10:00 am by Thursday 21st January 2021**.
7. The election procedure will be as follows:
 - a. Ballot Box will be sealed in the presence of the candidates and the Returning Officer duly appointed by the Council, on **Friday 22nd January 2021 at 09:00 am**.
 - b. All voting papers will be in original and will bear the signature of the Returning Officer and the official seal of the MBA.
 - c. No voting paper will be issued to any member who is in arrears on his/her membership fees with the Association.
 - d. Voting will start on **Friday 22nd January 2021 at 10:30 am**.

- e. Any compliant member who wishes to vote in absence, must call in person **with his/her Barrister Card** at the seat, to sign the necessary form to obtain a voting paper.
- f. Voting will end on **26th January 2021** at the AGM as soon as the Report of the President has been read.
8. Results of the election will be announced by the Secretary of the Council at the Seat immediately after counting on the same day. Counting will be supervised by the Returning Officer and his/her team as duly appointed by the Council.
