SWEARING OF AFFIDAVITS

All affidavits relating to urgent applications before the Supreme Court, will be sworn/solemnly affirmed at the New Court House, Pope Hennessy Street, Port Louis, Mondays to Fridays (other than public holidays) from 10.00am to 2.00pm.

CASHIER

The cash office at the New Court House, Pope Hennessy Street, Port Louis, will be open Mondays to Fridays (other than public holidays), from 10.00am to 2.30pm.

HEALTH SAFETY AND SANITARY MEASURES

Access to court premises will be subject to the following health, safety and sanitary measures:

- There will be one single controlled entrance to all courts and the temperature of all court users will be checked before they are allowed access to the court premises.
- Every court user will have to wear a protective face mask failing which access to the court premises will be refused.
- At the entrance post of every court, the name, address and contact details of every court user will be logged in a special register which will be used in the event of contact tracing exercise.
- Court users will be required to apply hand sanitizers which will be made available at the entrance.
- Court users will be required to observe physical distancing as per the established rules at all times in the court premises.
- Admission to court rooms and chambers will be limited and restricted in order to ensure compliance with safe distancing rules.
- In order to avoid overcrowding in courts, attorneys and counsel are requested to inform their clients in civil matters to abstain from attending Court during formal matters unless their presence is necessary and to avoid as much as possible the presence of pupils and attorney's clerks in court.
- Senior or leading counsel must, as far as possible, arrange to appear in court assisted by not more than one junior counsel.

VIRTUAL HEARING

The Court, Judge or Magistrate, as the case may be, may arrange for the virtual hearing of any urgent applications/motions subject to such conditions as may be imposed by the Court, Judge or Magistrate.
