Dear Members,

Further to the Communique regarding the forthcoming AGM 2022, we are pleased to inform you of the following:

1. Only compliant members (members who have paid their membership fees and are not in arrears with the Association) will be allowed to participate in the AGM.
2. Nomination papers will be made available at the Seat of the MBA on the 19th January 2022 as from 9am to 3pm for any member who wishes to stand as candidate for the election of the Bar Council.
3. A candidate must ensure that his/her nomination paper is duly deposited at the Seat of the MBA by 20th January 2022 at 15:00 p.m. latest. No nomination paper will be accepted after that time.
4. Every candidate must ensure that his/her nomination paper is duly signed by at least two compliant members of the MBA indicating clearly on the nomination paper, the members' postal addresses and email addresses.
5. The list of candidates will be communicated to all members of the Association on Friday 21st January 2022.
6. Withdrawal of candidacy should be done on or before 10:00 am by Friday 21st January 2022.
7. The election procedure will be as follows:
 - a. Ballot Box will be sealed in the presence of the candidates and the Returning Officer duly appointed by the Council, on Monday 24th January 2022 at 09:00 am.
 - b. All voting papers will be in original and will bear the signature of the Returning Officer and the official seal of the MBA.

- c. No voting paper will be issued to any member who is in arrears on his/her membership fees with the Association.
 - d. Voting will start on Monday 24th January 2022 at 10:30 am.
 - e. Any compliant member, who wishes to vote in absence, must call in person with his/her Barrister Card at the seat, to sign the necessary form to obtain a voting paper.
 - f. Voting will end on Friday 28th January 2022 at noon on the AGM day.
8. Results of the election will be announced by the Returning Officer at the Seat immediately after counting on the same day. Counting will be supervised by the Returning Officer and his/her team as duly appointed by the Council.
